Dear Mr. Buttars:

As indicated by the attached letter, the above referenced grievance has been withdrawn from Step 4 of the grievance/arbitration process.

The issue in the grievance was whether or not management violated the National Agreement when a certain mail piece(s) identified as a "Netflix" was not credited as a parcel during the mail count.

The language in the M-38 and the PO-603 is not supportive of a position claiming that a "Netflix", or similar mail piece(s), should be credited as a parcel during a mail count. Further, although the mail piece in this case is distinguishable from the mail piece at issue in the CD in the magazine grievance that was denied by a national arbitrator, the principles involved are nearly identical. Therefore, it is not reasonable to expect that any persuasive argument can be made to obtain flat credit. Letter credit is not inappropriate.

After careful review of the grievance file and considerable discussion of the issue, it was determined that there would be no reasonable likelihood of success in arbitration. The grievance has been withdrawn and the case is now closed.
