

NATIONAL WORK HOURS REPORTS

As part of our on-going efforts to enforce the Collective Bargaining Agreement, the NRLCA now receives detailed reports from the USPS on regular carrier work hours. Each pay period, the total work hours reported by regular carriers are consolidated into a report and the data is sent to the union. We have verified the accuracy of this information by polling hundreds of regular carriers and using comparisons to their hard copy 4240s.

The NRLCA National Board has decided to make the National Recap Reports available to the membership via the NRLCA web site. Please understand that this National Recap includes every rural route on which a regular carrier worked that pay period. If no regular carrier worked the route, the route is not included in that week's report. Only hours worked by a regular carrier on their assigned route are included. So, the number of regular carriers will vary from week to week depending the number of carriers on leave for the entire week.

Here is a quick explanation of each column in the chart:

PAY PERIOD/WEEK: The Pay Period and either week 1 or 2 of the Pay Period.

DATES: The dates covered by that PP/Week

TTL REG CARRIERS: The total number of regular carriers who worked the route that week.

REG CARRIERS OVER EVAL: The total number of regular carriers who worked more than their evaluated hours that week. This is adjusted to reflect the number of days worked. For example: if a carrier only worked one day but worked 9 hours on a route that evaluated at 8 hours per day, the report would reflect one hour over evaluation for the week.

% CARRIERS OVER EVAL: The percent of regular carriers who exceeded their evaluated hours for the week.

AVG HRS OVER EVAL: Of the regular carriers who exceeded their weekly evaluated hours, the average hours over evaluation. This column only includes the carriers who exceeded their weekly evaluation.

AVG +/- ALL REG CARRIERS: This figure includes all regular carriers who worked and all hours they worked compared to the evaluated hours. This is what has always been called the "over/under."

AVERAGE: This is the average of each column. This number will change as we add additional Pay Periods to the table.

The Board hopes that this information will stimulate discussion and thought on the current realities of the evaluated system and help us all to make decisions going forward.
